## 3. Payment Arrangements

Cancellation less than 12 weeks before the date of the wedding will require payment in full. All cancellations must be in writing. The cancellation conditions above will apply for postponed weddings if the photographer is not able to reschedule for the new date and time. The fee for postponed weddings is subject to change.

#### **4. Copyright**

The entire copyright of the photographs is retained by the photographer at all times throughout the world. Where a disc of photographs has been provided to the bride and groom as part of their wedding collection, the photographs may be printed, and displayed online, for personal but not commercial use. The photographer retains the right in all cases to use the photographs in any manner, at any time and in any part of the world for the purposes of advertising or otherwise promoting his work.

#### **5. Image, Size, Color, Style and Composition**

All image sizes are approximate. The photographer will provide a pleasing color balance but can not guarantee exact color matching. It is sometimes not possible to record on film or in print exact colors as seen by the human eye. There is no right to reject on the basis of style or composition. The final post production and editing styles, effects and overall look of the images are left to the discretion of Foschini Photography.

#### **6. Attendance**

In the unlikely event the photographer is unable to complete the coverage due to unforeseen circumstances, the photographer reserves the right to appoint another photographer to attend on his behalf to undertake the photography. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event(s).

#### **7. Limitation of Liability**

In the unlikely event the digital files have been lost, stolen or destroyed for reasons beyond the photographers control, or of a total photographic failure, including but not limited to camera, hard drive or equipment malfunction, the photographers liability is limited to the return of all payments received for the event(s).

#### **8. Capture and Delivery**

Foschini Photography is not liable to deliver every image taken at the event. The determination of images delivered to the client is left to the discretion of Foschini Photography. Client understands and agrees under no circumstance will raw, unedited, original files be released to client. Final delivery of edited images is approximately 6-10 weeks.

#### **9. Meals**

Client/Wedding Couple agrees to provide a meal for Foschini Photography and their employees.

#### **10. Indemnity**

The client shall be responsible for obtaining any and all clearances and will indemnify the photographer against all expenses, damages, claims and legal costs arising out of any failure to obtain such clearances.
