A 50% deposit to secure the date is due upon signing of this contract, with the balance to be paid in full two weeks (14 days) prior to the event date. In the event of a cancellation this deposit is non-refundable or transferable, it being the agreed loss suffered by FOSCHINI PHOTOGRAPHY due to cancellation.

FOSCHINI PHOTOGRAPHY accepts cash, check, money order, Venmo & Pay Pal as forms of payment. Payments must be made in US Dollars (USD) and drawn from a bank operating in the United States. The Client, as listed above, shall be charged \$35.00 USD for each check returned unpaid by the bank for any reason plus a \$50.00 USD late fee.

Date Changes & Cancellations

Any request for a date change must be made in writing at least thirty days in advance of the original event date. Change is subject to audio guestbook availability and receipt of a new Service Contract. If there is not availability for the alternate date, the deposit shall be forfeited and event cancelled.
